Any person interested in purchasing any of the specified residential properties (“<b>Prospective Purchaser</b>”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> <li>(a) personally attend the ICC Venue; and</li> <li>(b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the Prospective Purchaser, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$100,000 and made payable to “MAYER BROWN JSM”.</li> </ol> </li> <li>2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the ICC Venue before the commencement time of sale.</li> <li>3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).</li> <li>4. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall <b>personally</b> enter into one or more Preliminary Agreement(s) for Sale and Purchase of the specified residential property(ies) successfully selected by him/her/it. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 6:00 p.m. on any date of the sale, for the safety of the Prospective Purchasers and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to close the ICC Venue. Prospective Purchasers will not be notified separately of the arrangement.

1. 先到先得。任何有意購買指明住宅物業的人士（下稱「準買方」）（如準買方是公司，則其任何一位董事）須遵從下列程序：
    - (a) 親臨 ICC 會場；及
    - (b) 攜同其香港身份證/護照正本及本票及(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。本票的數目需與準買方將購買的指明住宅物業的數目相同，惟該住宅物業數目不能多於兩(2)個。每張本票金額為港幣\$100,000 及抬頭人須為「孖士打律師行」。
